The governing body is responsible for maintenance of this scheme.

1. Introduction: what a publication scheme is and why it has been developed

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- *The classes of information which we publish or intend to publish;*
- *The manner in which the information will be published; and*
- *Whether the information is available free of charge or on payment.*

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme is available in paper form.

Some information which we hold may not be made public, for example personal information. This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

2. Aims and Objectives:

Rainham Mark Grammar School aims to be a friendly, caring and stimulating community which motivates young people to enjoy learning, participate enthusiastically in wider activities and make the most of their abilities.

Through its broad curriculum and diverse teaching and learning strategies, RMGS aims to secure high academic achievement for young people and to help them mature into confident, well-motivated individuals who can make the most of their opportunities and enrich the wider community.

RMGS is a school with values founded on respect:

- Respect for each other and ourselves.
- Respect for hard work and scholarship.
- Respect for diversity of achievement.
- Respect for community and environment.

Aims:

- To enable our pupils to learn about themselves and the wider world and acquire knowledge, understanding and qualifications which will be of value to them through life.
- To provide a stable and stimulating environment within which pupils can develop their intellectual, aesthetic, cultural, social and physical talents.
- To help pupils consider carefully key moral, religious and spiritual aspects of life.
- To prepare pupils to become active, considerate citizens in society and make well-informed choices.
- To have high expectations of individual performance and behaviour.
- To provide stimulating and challenging teaching and learning materials for all pupils.
- To involve parents in supporting their child's learning and the aims of the school.
- To promote equal opportunities.
- To develop all staff in line with the Investors in People (IiP) standards.
- To provide professional support and guidance for those training to be teachers.

- To provide appropriate access for some community activities.
- To maintain a co-educational ethos.
- To maintain a six-form entry to Year 7.

Objectives:

- To ensure the curriculum provides appropriate activities and experiences for pupils to develop our aims and meet national requirements and targets.
- To develop resources, materials and approaches which fulfil our aim to provide stimulating and challenging teaching and learning materials for all pupils.
- To evaluate these resources, materials and approaches which enable provision of stimulating and challenging teaching.
- To provide positive reinforcement through clear and fair discipline and recognising and rewarding pupils' efforts and achievements.
- To evaluate (and change where necessary) the organisational practices of the school in helping staff and pupils to achieve their aims.

The school aims to:

- Enable every child to fulfil their learning potential, with education that meets the needs of each child,
- Help every child develop the skills, knowledge and personal qualities needed for life and work, and this publication scheme is a means of showing how we are pursuing these aims.

3. Categories of information published

The publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as 'classes'. These are contained in section 6 of this scheme.

The classes of information that we undertake to make available are organised into four broad topic areas:

School Prospectus – information published in the school prospectus.

Governors' Documents – information published in the Governors Annual Report and in other governing body documents.

Pupils & Curriculum – information about policies that relate to pupils and the school curriculum.

School Policies and other information related to the school - information about policies that relate to the school in general.
